Whereas, the J&K Services Selection Board has issued Notification for the Selection List of Junior Engineer (Civil) in Jal Shakti Department, advertised vide Notification No. 01 Of 2021 dated 03.02.2021 (Item No. 001) and forwarded the same to the Indenting Department under endorsement No. SSB/Secy/Sel/2022/5666-75 dated 03.08.2022; and


Whereas, among the selectees, the recommendation of Mr. Ashiq Hussain Bin Mushtaq S/o Mushtaq Ahmad Ganie R/o District, Ganderbal, figuring at Sr. No. 33/OM/HCL category, was kept withheld subject to production of Valid Disability Certificate; and

Whereas, the J&K Services Selection Board served a Notice to Mr. Ashiq Hussain Bin Mushtaq vide letter No. JKSSB-ADM/134/2022 dated 10.03.2023 to submit the requisite documents in original; and

Whereas, this was followed by Final Notice vide No. JKSSB-ADM/134/2022 dated 06.04.2023 advising the candidate to submit the requisite documents in original within 07 days; and

Whereas, despite the lapse of considerable time, the candidate did not submit the requisite Certificate and, accordingly, the above withheld recommendation case was placed in the 227th Board Meeting, which, taking note of the fact that despite sufficient time/opportunities afforded to Mr. Ashiq Hussain Bin Mushtaq, the said candidate has failed to produce the requisite document (Valid Disability Certificate) and, accordingly, decided to cancel his withheld recommendation.

Now, therefore, the withheld recommendation of Mr. Ashiq Hussain Bin Mushtaq S/O Mushtaq Ahmad Ganie R/o District, Ganderbal, figuring at Sr. No. 33/OM/HCL category, Roll No. 1045952, for the post of Junior Engineer (Civil) in Jal Shakti Department, advertised vide Notification No. 01 Of 2021, Item No. 001 dated 03.02.2021, is hereby cancelled.
