Consequent upon the receipt of indent/requisition from the Finance Department, vide Indent No. FD/Coord/08/2020 dated 19.11.2020 and No. FD/Coord/08/2020 dated 20.11.2020, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts, advertised 01 post of Library Assistant in OM category, vide Notification No. 04 of 2020 dated 16.12.2020, under Item No. 110.

The JKSSB conducted the Computer Based Test (CBT) for the aforementioned post and, thereafter, on the basis of merit obtained by the candidates, the Document Verification was conducted. The above Selection list shall be subject to the outcome of writ petition(s), if any, pending disposal before any competent Court of jurisdiction related to the selection.


The Selection List shall also be subject to the outcome of any inquiry, involving candidate(s), figuring in this Selection List.
