


However, the Hon'ble Central Administrative Tribunal, Jammu Bench, vide order dated 10.11.2023 has disposed of the OA and passed the following directions:

"The Original Application is disposed of at the admission stage, without entering into the merits of the case with a direction to respondents to treat a copy of this Original Application as representation of the applicant and decide the same by passing a reasoned and speaking order. While taking a decision in the matter, the respondents should also consider the judgments of Hon'ble Supreme Court, Hon'ble High Court of Jammu and Kashmir and orders of this Tribunal annexed with the Original Application. The applicant shall also be afforded an opportunity of hearing. The whole exercise shall be undertaken within a period of four weeks from the date of receipt of a certified copy of this order."
