**Subject: Selection List of candidates for the posts of "Draftsman (Civil)", UT Cadre in Public Works (R&B Department), advertised vide Notification 05 of 2020 dated 24.12.2020, under Item No. 132- Recommendation for unfilled slot thereof.**

Sir,

Consequent upon the receipt of indent/requisition from the Public Works Department, vide Indent No. PW(R&B)NG/124/2019 dated 30.09.2020 and Indent No. PW(R&B)NG/124/2019 dated 17.12.2020, the J&K Services Selection Board initiated the process for selection, among others, for 34 posts of Draftsman Civil under Item No. **132 (UT cadre)** with the following breakup:

As per the criteria adopted, the JKSSB conducted Computer Based Test (CBT) for selection of candidates w.e.f. 27.10.2021 to 02.11.2021 & 08.11.2021 to 12.11.2021 in multiple shifts/sessions and the result of the said examination was declared vide Notification No. SSC/COE/CBT/2021/8929-36 dated 20.12.2021. On the basis of merit obtained in the result, the candidates falling within the consideration zone were called for document verification vide Notice No. SSB/OE/CBT/2022/211-18 dated 08.01.2022 and the Supplementary DV was held on 14.02.2022, for candidates falling under consideration zone.

Accordingly, the Selection Committee, in accordance with the rules governing the subject and following the principle of *merit-cum-preference*, prepared the Final selection list for the aforementioned posts, which was notified

vide Notification No. SSB/Sel/Secy/2022/2885-90 dated 19.03.2022 and forwarded to the R&B Department vide letter No. SSB/Sel/Secy/S/UT/2022/3355-60 dated 25.03.2022.

In the Selection List so forwarded, the following slots/vacancies were kept unfilled:

Pursuant to the above, the Board, considered the selection for the above-mentioned unfilled slots in the said list under Item No. 132 and, accordingly, approved filling up of these vacant slots from among the candidates figuring next in order of merit in its 220<sup>th</sup> Board Meeting.

Accordingly, the unfilled slot in the SC category at Sr. No. 02 (waiting list) was filled up by considering Mr. Raman Kumar, S/o Mr. Madan Lal, R/o H No. 356 L No 8 Rajpura Mangotrian, Ward No. 27, Jammu, 180001, with DV No. 295 JMU, Roll No. 1026992, D.O.B. 31/12/1992 and a percentile of 62.829403606, with the qualification of 2 years certificate course in Draughtsman Civil from DOTE, J&K, completed in 2015, against it. However, the unfilled vacancy under PSP at Sr. No. 01 could not be filled up for want of an eligible candidate. Consequently, no waiting list against it could be drawn.

In view of the above, the undersigned is directed to forward the recommendation of the above-mentioned candidate namely Mr. Raman Kumar, S/o Mr. Madan Lal, for the post of "Draftsman (Civil)", UT Cadre in Public Works (R&B Department), advertised vide Notification No. 05 of 2020 dated 24.12.2020, under Item No. 132, and return the unfilled vacancy under PSP category herewith.

The above recommendation shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Selection List shall also be subject to the outcome of any *inquiry*, involving the candidate.


The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and

ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

It is further requested that in case any certificate/document, during the course of verification, turns out be fake/fictitious, the Board may kindly be intimated and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their verification rolls in triplicate before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
