
Subsequently, the above-mentioned candidates submitted the requisite certificates/documents/affidavits and, accordingly the case was further examined and placed before the Board in its 223<sup>rd</sup> Board Meeting, wherein it was decided to release the aforementioned withheld recommendation, with necessary corrections in the name and in the father's name of the candidate.

Accordingly, the undersigned is directed to convey the above decision regarding the release of the withheld recommendation with the corrections in particulars, wherein the name of the candidate may be read as **Provinder Singh** instead of Parvinder Singh and his father's name as **Mokhin Singh** instead of Makhan Singh, for further necessary action at your end.
