**Whereas,** the aforementioned 122 Division Cadres posts of Draftsman Civil were subsequently advertised by the Jammu and Kashmir Services Selection Board vide Notification No. 01 of 2021 dated 03.02.2021 under Item No. 002 & 003; and

**Whereas,** as per the Notification No. 05 of 2020, the qualification prescribed for the posts of Draftsman Civil in Public Works Department is as under:

## "Two Years Draftsman Training Course Certificate/Diploma in Civil Engineering from Government recognized Institute".

**Whereas,** the Public Works Department vide letter No. PW(R&B)/NG/124/2019 dated 29.12.2020 had intimated that typographical error occurred in the column mentioning qualification/indent for the post of Draftsman Civil and Draftsman Mechanical in the aforesaid indent and they have mentioned that the actual qualification for the post of Draftsman (Civil) and Draftsman (Mechanical) is as under:

"Two Years Draftsman Training Course Certificate/Diploma from any Government recognized Institute".

**Whereas,** the Jammu and Kashmir Services Selection Board vide No. SSB/Secy/Advt.No./2021/228-243 dated 11.01.2021 issued corrigendum to the aforesaid advertisement notification No. 05 of 2020 to the effect that the prescribed qualification for the post of Draftsman Civil UT cadre under Item No. 132 shall be as under:

"Two Years Draftsman Training Course Certificate/Diploma from any Government recognized Institute".

Whereas, due to the aforesaid amendment in the advertisement notification No. 05 of 2020 the qualification prescribed for the posts of

Draftsman Civil for both the indenting Departments as mentioned in the respective Indents/ subsequent Advertisement Notifications becomes as under:

"Two Years Draftsman Training Course Certificate/Diploma from any Government recognized Institute".

**Whereas,** the criteria adopted by the Board for making selection to the post of Draftsman Civil was also notified in the Advertisement Notifications as under:

## "The selection for the posts shall be made on the basis of merit obtained in written examination only".

Whereas, as per the criteria adopted, the Jammu and Kashmir Services Selection Board conducted Computer Based Test (CBT) for selection of candidates w.e.f., 27.10.2021 to 02.11.2021 & 08.11.2021 to 12.11.2021 in multiple shifts/sessions and the result of the said examination was declared vide Notification No. SSC/COE/CBT/2021/8929-36 dated 20.12.2021 and on the basis of merit obtained in the result, the candidates falling within the consideration zone were called for document verification vide Notice No. SSB/OE/CBT/2022/211-18 dated 08.01.2022 and the Supplementary DV notice was issued vide No SSB/COE/CBT/2022/1273-80 dated 14.02.2022, for candidates falling under consideration zone; and

**Whereas,** a Selection Committee was also constituted by the J&K Services Selection Board vide Order No. 30-SSB of 2022 dated 28.01.2022; and

**Whereas,** since, the CBT was conducted for all the cadres for the posts of Draftsman Civil, the Jammu and Kashmir Services Selection Board sought online preferences from the candidates from 09.02.2022 to 11.02.2022 in respect of notified cadres, so as to consider only one candidate for single post in accordance with merit cum preference method; and

**Whereas,** the Selection Committee in accordance with the rules governing the subject and following the principle of merit-cum-preference prepared a Provisional Selection List of UT Cadre posts of Draftsman Civil under Item No. 132 and the said provisional list was notified vide Notification No. SSB/Secy/Sel/2022/1623-32 dated 23.02.2022. Similarly, the provisional selection lists for Division Cadre Kashmir and Division Cadre Jammu were

notified vide Notification No. SSB/Secy/Sel/2022/1635-44 dated 23.02.2022; and

Whereas, the Final selection list was notified vide Notification No. SSB/Sel/Secy/2022/2885-90 Dated 19.03.2022 and forwarded to the R&B vide letter No. SSB/Sel/Secy/S/UT/2022/3355-60 25.03.2022 and to Jal Shakti Department vide letter no SSB/Sel/Secy/J/K/D1/2022/3349-54 Dated 25.03.2022, respectively; and

Whereas, it was observed that under item no 132, 01 (one) slot in the waiting list for SC category at Sr. No.2, and two (2) slots, one in the selection list and one in the waiting list under PSP category both at Sr. No. 1, had been kept unfilled for want of certain clarification. Also, under **item no 002**, one (1) slot in the waiting list of Open merit at Sr. No. 17, one (1) slot in the waiting list of SC category at Sr. No. 2 and two (2) slots in the selection list of EWS category at Sr. No. 6 and 7 had been kept unfilled for want of certain clarification and there was no waiting list for EWS category in the said item number. Also, under item no 003, two (2) slots in the selection list for OM category at Sr. No. 18 and 25 and one (1) slot in the waiting list of OM at Sr. No. 09, were kept unfilled for want of certain clarification. Also, one (1) slot in the waiting list under ST category at Sr. No. 03 was also kept unfilled for want of certain clarification. In the selection list for RBA category, one (01) slot at Sr. No. 05 had been kept unfilled for want of certain clarification. In the selection list for EWS category, two (02) slots at Sr. No. 03 and 04 had been kept unfilled for want of certain clarification; and

**Whereas,** the Board in its 213<sup>th</sup> Board Meeting constituted a sub-committee to examine/review the filling up of the unfilled slots in the said list under item no. 132, 2 and 3. The committee examined the available record and the observations of the sub-committee were placed before the Board in its 220<sup>th</sup> meeting held on 16.02.2023 and after due deliberations on the observations, the Board decided that the vacant/reserved slots shall be filled up by the candidates who are figuring next in order of merit.

#### Now, therefore:

(i) The reworked lists, for the posts of "**Draftsman Civil**" in Public Works(R&B) Department for UT Cadre (Notification No. 05 of 2020, Item No. 132) and Jal Shakti Department for Division Cadre Kashmir (Notification No. 01 of 2021, Item No. 002) and Division Cadre Jammu (01 of 2021, Item No. 003), indicating
